Our Purchase Agreement

It is hereby agreed by both parties that the following conditions will be met and that no other warranties or conditions are expressed or implied.

The Buyer understands that deposits, whether for a waitlist or puppy, when made cannot be undone and are to be considered NON-REFUNDABLE. Buyer understands that he /she will forfeit their deposit, if for any reason, he / she decides to no longer purchase a puppy or wishes to choose a different puppy.

The buyer understands that puppies will need to be picked up at 8 weeks of age. The buyer understands that additional fees may be applied if, for any reason, he / she cannot pick up the puppy within 3 days of the designated pick up date and if the puppy is to remain with the breeder.

The buyer understands that all puppies are classified as a PET by the seller, and will be sold contingent on the understanding that the puppy(ies) will be spayed / neutered BEFORE they reach 12 months of age. The buyer furthermore understands that the breeder, Harper Family Corgis, must receive proof of spay / neuter by email at HarperFamilyCorgis@gmail.com.

The buyer understands, that if the puppy or puppies receives a poor health diagnosis within 72 hours of leaving the breeder, Harper Family Corgis, for a life-threatening or congenital (existing at birth) condition that existed PRIOR to the purchase of the puppy or puppies, and NOT due to negligence, injury, or a contaminated environment caused by the buyers after taking possession of the puppy or puppies, that TWO statements from separate facilities and only by licensed veterinarians describing the puppy or puppies condition(s) must be provided to the breeder, Harper Family Corgis, on official letterhead within 24 hours of the dated official statements. The buyer furthermore understands, that if the puppy or puppies is / are found to have said life threatening or

congenital (existing at birth) condition(s) PRIOR to leaving the breeders possession, that a new puppy of equal value will be provided to the buyer, when first available and not to interfere with waitlist applicant(s), and that NO REFUND will be available to the buyer.

The buyer understands that the breeder, Harper Family Corgis, offers a one-year health guarantee against genetic defects and congenital condition(s). The buyer furthermore understands that the breeder, Harper Family Corgis, is NOT held responsible for the puppy or puppies health upon the buyer taking possession of the puppy or puppies at 8 weeks of age, including but not limited to communicable diseases such as: distemper, hepatitis, leptospirosis, parvovirus, parainfluenza, lyme, bordatella, corona, rabies, etc.

**** The buyer understands and furthermore certifies that they are purchasing this puppy or puppies for themselves and not acting on behalf of another individual. The buyer understands and furthermore certifies that this puppy or puppies CANNOT be re sold or given away, but must be returned to the breeder, Harper Family Corgis, with NO refund, and with the same documents he / she was delivered: AKC Registration Paperwork, Pedigree, etc.**
